I remain committed to protecting and strengthening our neighborhood schools, but we must also acknowledge that EPISD had over 60,000 students enrolled a decade ago—today, that number has declined by 12,000, yet we continue to operate with a much greater number of near-empty schools. This decision was crucial to preserving high-quality programming, expanding opportunities for student success, and ensuring job security for all EPISD employees—without placing a greater financial burden on taxpayers.

I am running for the school board because I believe in the power of public education to transform lives.
